Release Waiver And Indemnity - All players must read and sign this Waiver, Release of Liability and Assumption of Risk Agreement and return a copy to the Solidarity SlugFest Coordinator prior to playing any games.

- It is the responsibility of each Team Captain and all individual registrants to ensure that only registered players compete in The Solidarity SlugFest games.
- All registrants in the Solidarity SlugFest are subject to NSA Rules and Regulations. It is the responsibility of each registrant to obtain and read the Rules and Regulations from the Team Captain or access them online.

The undersigned hereby acknowledges, having read and understood the foregoing, and agrees to the same in all respects. Further, in consideration of being allowed to participate in any way in the Solidarity SlugFest, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from activities involved in this Solidarity SlugFest is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce the risk, the risk of serious injury does exist; and
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releasees (defined below) or others, and assume full responsibility for my participation, and
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual significant hazard during my presence or participation I will remove myself from participation and bring such to the attention of the nearest official immediately, and
4. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby waive any and all claims that I have or may have in the future against the Solidarity SlugFest Planning Committee, Affiliated Unions, The Building Trades of Alberta, Vida Events Inc. NSA, Okotoks on Deck, and their respective officers, agents, and or employees, other participants, sponsoring agencies, sponsors, advertisers, volunteers, and if applicable, owners and lessors of premises used to conduct activities with respect to any and all injury, disability, and death or loss or damages to person or property, whether caused by the negligence of the releasees or otherwise related to my participation in the Solidarity SlugFest in any way.
